People Count packages US Census data about race and ethnicity into easy-to-use text and tables for a candid look at the different places and racial, ethnic, and cultural groups of Sarasota County.

What is in People Count: Race and Ethnicity ?

Description - Because the different places of Sarasota County are unique, People Count: Race and Ethnicity starts by describing the highlights of each. Here you will find interesting facts accompanied by graphs and tables.

Tables - Tables customized for Sarasota County sort numbers from the US Census by theme - age, education, poverty, and housing are a few examples of table themes. Each table starts with a question about the table's theme and provides the answer with data from the 1990 and 2000 US Censuses.

How do I use People Count: Race and Ethnicity ?

The Census divides Sarasota County into seven Census-designated geographies: Englewood, Gulf Gate - Osprey, Longboat Key, North Port, Sarasota, Venice, and the Interior County. The data in this report covers these geographies and Sarasota County as a whole. See the reference map on page 3.

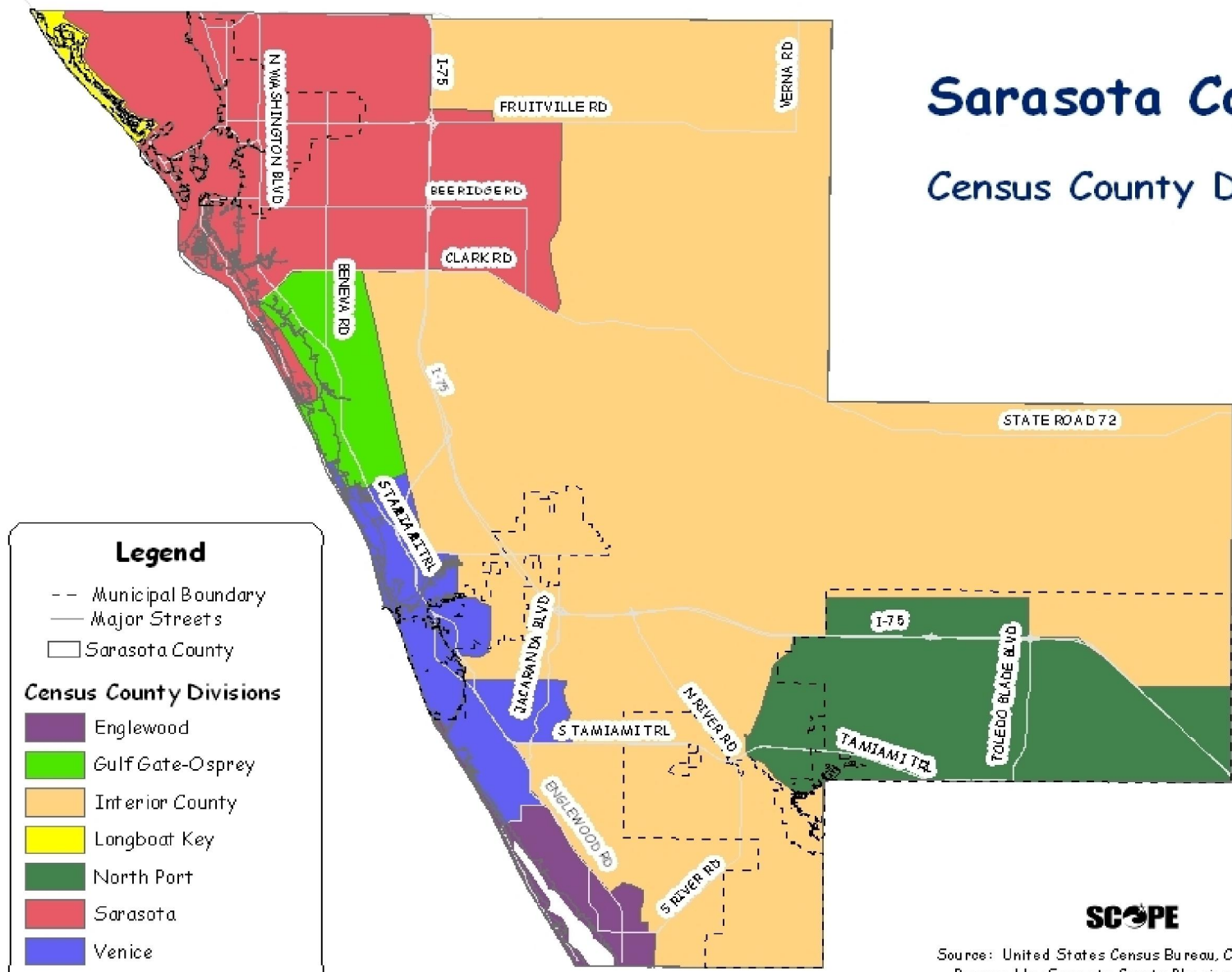
In each of these geographies, you will see the five most common racial and ethnic groups: white, black or African American, Hispanic or Latino, Asian, and American Indian and Alaska Native (abbreviated AI / AN). In the tables, there is also an "All" category that represents the entire population in an area regardless of race.

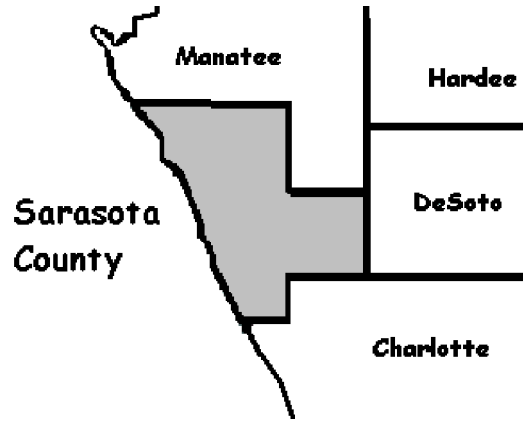

Sarasota County: Census 2000 Highlights



Population

- § 325,957 people lived in Sarasota County.
- § The overall population grew 17% from 1990 to 2000.

Families

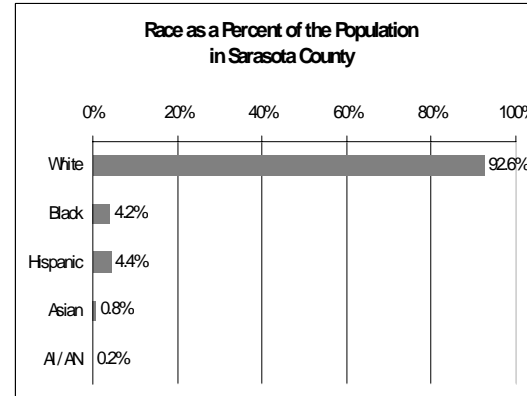
Across all groups, there were proportionally fewer married couples with children under 18. Also, single mothers with children under 18 kept pace with, and in some cases surpassed, the growth of the general population. Some facts about seniors:

- § Whites had the highest proportion of elderly householders, 44% of all whites were over the age of 65, 39% of those elderly whites lived alone.
- § Although Asians had the lowest percentage of householders over 65 – 4% of all Asian householders – 48% of those elderly householders lived alone (the highest of any group).



Workforce

- § White people had the lowest percentage of their population participating in the labor force and the lowest proportion unemployed.
- § American Indians and Alaska Natives had the highest unemployment levels: 9% in 2000, 10% in 1990.
- § 81% of whites and 80% of Asians drove alone in their cars to go to work.
- § Blacks and Hispanics were more likely to use other forms of transportation in their commute: 20% of Hispanics carpooled, 6% of blacks used public transit and 6% biked or walked to work. (continued below)



Age

Whites had a higher proportion of elderly people than youth, the opposite of all other groups.

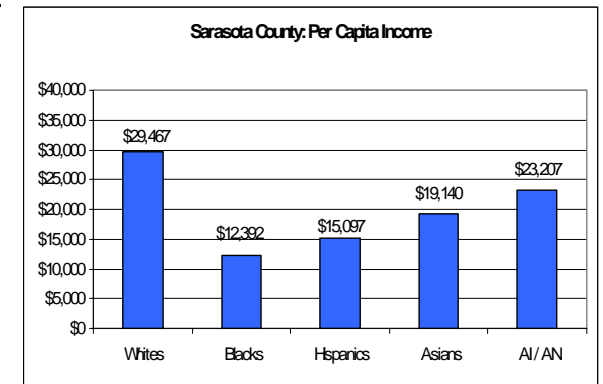
Education

Those without a high school diploma or equivalent decreased both in number and in proportions. The reverse happened with college degrees; there were more people in both number and proportion who had some sort of college degree.

- § 9% of white people lacked a high school diploma or its equivalent; down from 18% in 1990.
- § Those numbers for African Americans decreased from 46% to 39%.
- § 15% of African Americans had a college degree, up from 13% in 1990.
- § Hispanics were the only group whose population without a high school diploma or equivalent increased.
- § Asians had the highest percentage of people with college degrees: 32% in 1990 and 42% in 2000.

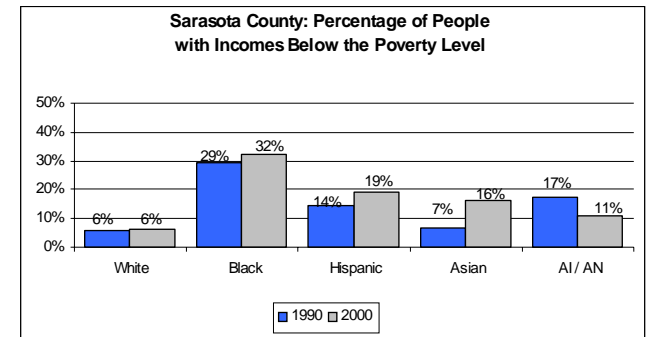
Income and Poverty

The overall per capita income for Sarasota County was \$28,326.



- § In two-parent families, Blacks and Hispanics were more likely than any other group to have only one of those parents in the labor force.
- § Among American Indian and Alaska Natives, 100% of single parents were in the labor force.

Poverty increased for all groups except the American Indians and Alaska Natives.

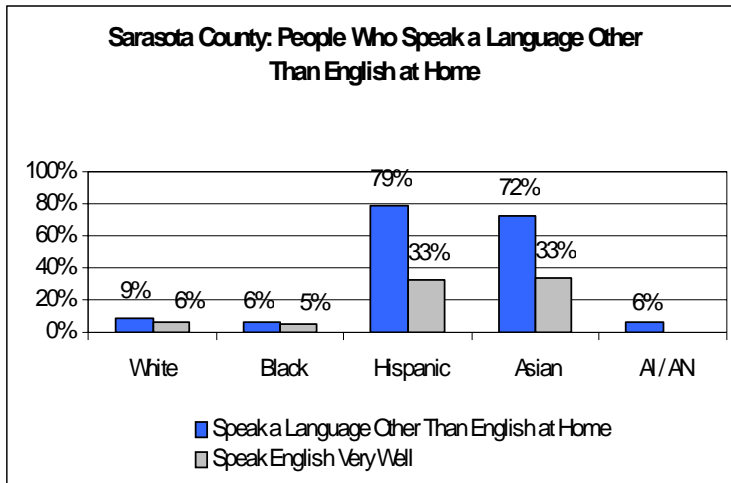


Housing

Renters were more likely than owners to be cost-burdened, that is, paying 30% or more of their income to housing payments. Also, the majority lived in detached, single family homes.

- § American Indians and Alaskan Natives had the highest percentage of people living in single-family homes, 78%
- § 33% of both blacks and 28% of Hispanics lived in multi-family units.
- § A higher proportion of whites lived in mobile homes than any other group: 10% of all white householders lived in mobile homes.

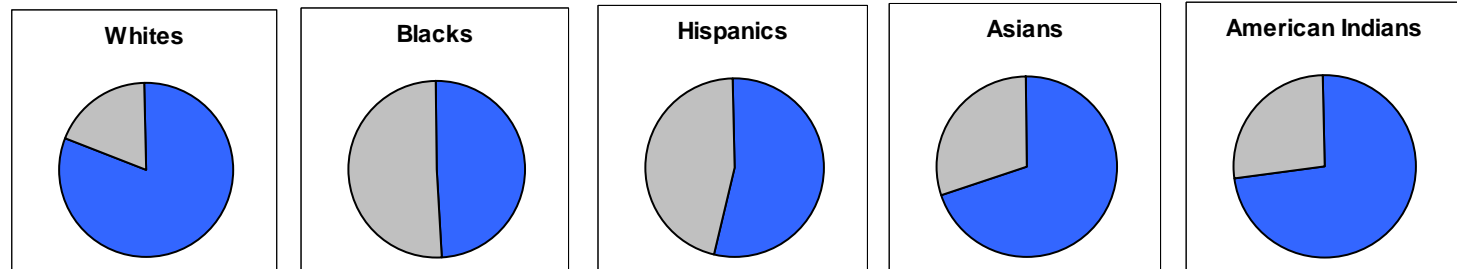

- § 75% of whites were born in a state other than Florida.
- § 67% of blacks were born in Florida.
- § 57% of Hispanics were foreign-born.
- § 73% of Asians were foreign born.
- § 79% of American Indians were born in a state other than Florida.

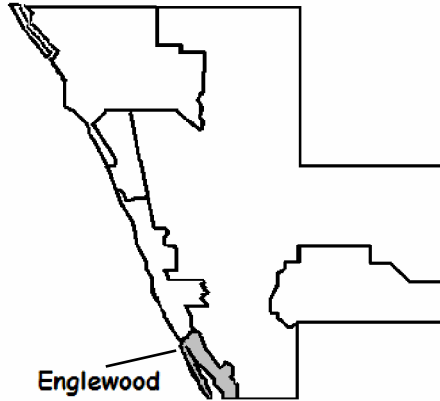

- § 12,631 people lived in Englewood.
- § The overall population grew 4% from 1990 to 2000.



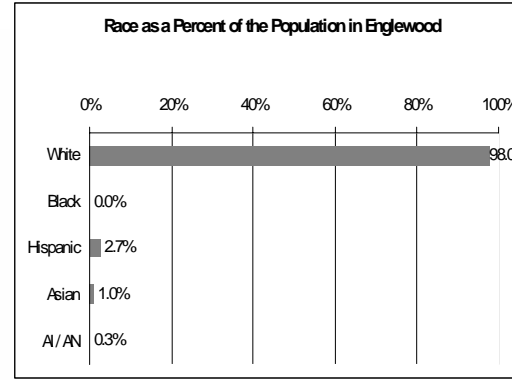
Family Structure

- Compared to the rest of the county, there were proportionally fewer married couple households with children under 18 in Englewood. Also, only one group had households with single mothers:
- § White single females with children increased 131% to represent 3% of all white householders.
 - § 57% of all white householders were over the age of 65, 35% of people in this group lived alone.
 - § 59% of all American Indian householders were over the age of 65, however, none of them lived alone.



Workforce

- § Whites had the smallest proportion of people participating in the labor force: 37%.
- § Most workers in Englewood drove alone to work — 83% of whites, 90% of Hispanics, and 100% of Asian workers commuted that way.
- § Of Hispanic youth with two parents, 54% had both parents in the labor force. 100% of Hispanic youth with one parent had that parent in the labor force.



Age

Seniors made up almost half of the entire population of Englewood.

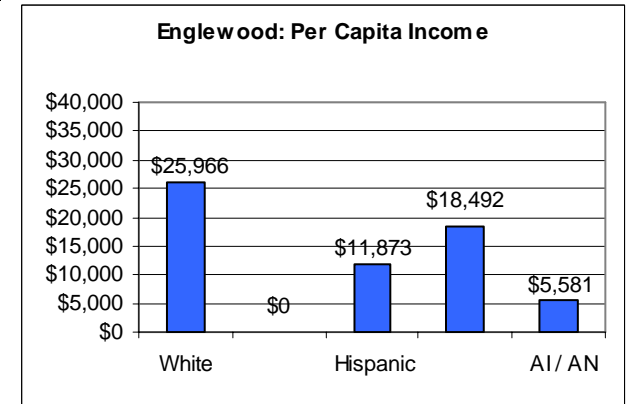

Educational Attainment

- The increase in people with college degrees was not as dramatic here as in other parts of the county. There was complex change in the population who lacked a high school diploma or its equivalent:
- § The proportion of whites who lacked a high school diploma or equivalent decreased 11 percentage points from 21% of whites in 1990 to 10% in 2000.
 - § The proportion of Hispanics without a high school diploma increased from 18% to 34% of the population.
 - § 100% of American Indians lacked a High School diploma or equivalent in both 1990 and 2000.

Income and Poverty

The overall per capita income in Englewood was \$25,815.

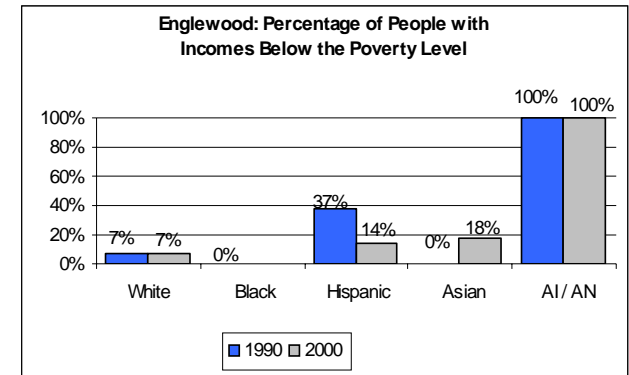

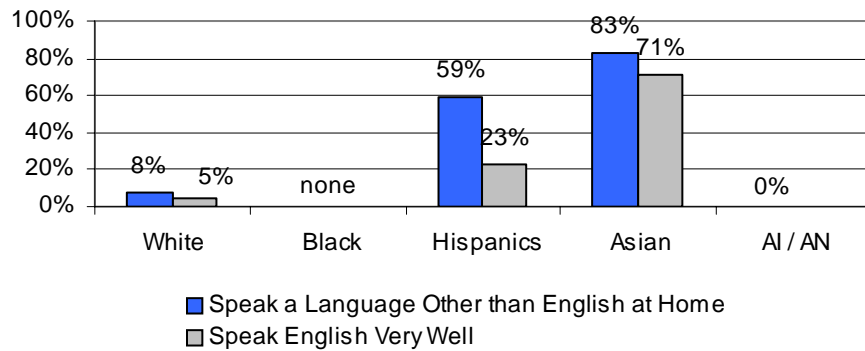
Most people in Englewood were born in another American state or territory. There were slightly lower proportions of foreign-born people among typical immigrant groups like Hispanics and Asians.

- § 83% of whites were born in a state other than Florida.
- § 46% of Hispanics were born in a state other than Florida, 44% were foreign-born.
- § 54% of the Asians were born in another country, 61% were citizens.
- § Asians had the highest proportion of people born in Florida: 29%.
- § 90% of American Indians were born in another state, with most – 85% — being from the south.

The American Indian and Alaska Native population is small (43 people) but 100% live below the poverty line.

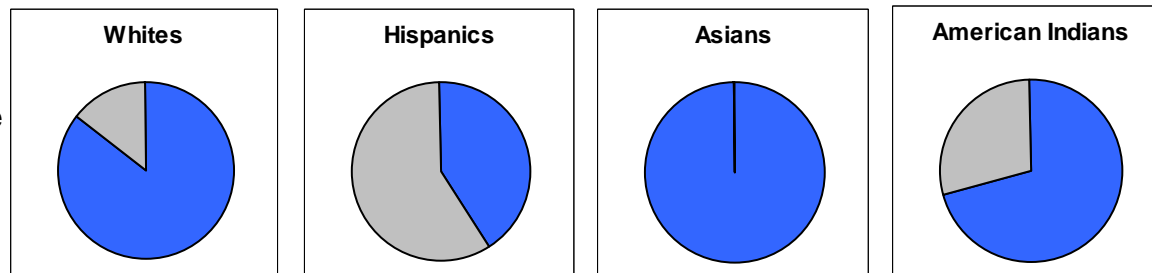
The majority of all groups lived in single family homes: 73% of whites, 67% of Hispanics, 100% of Asians, and 70% of American Indians.

- § Of whites who did not live in a single family home, 12% lived in multi-family residences and 15% lived in mobile homes.
- § The reverse proportion was true for Hispanics, with more living in multi-family residences than mobile homes (21% and 12% respectively).

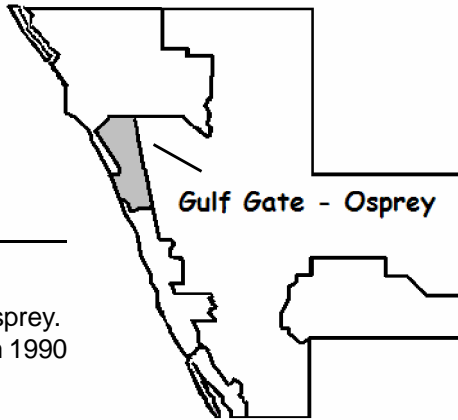

- § 27,217 people lived in Gulf Gate – Osprey.
- § The overall population grew 24% from 1990 to 2000.

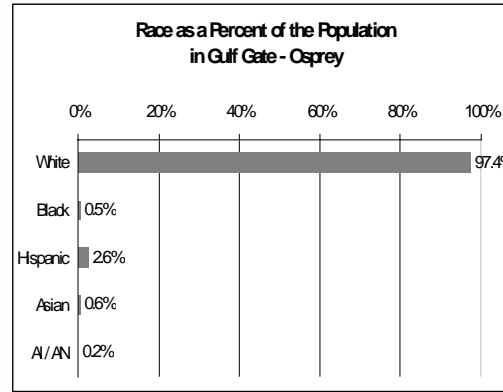
Family Structure

There were very few households with a single mother and children. Households headed by a senior citizen were primarily of one race:

- § 47% of white householders were over 65, 42% of those elderly householders lived alone.
- § Married white householders living with their children were 11% of all white householders in both 1990 and 2000.
- § Although they had the highest proportions of married householders with children in 2000, Hispanic householders who were married with children changed dramatically, decreasing from 69% in 1990 to 29% in 2000.
- § Asians saw a similarly dramatic change in the proportion of married householders with children, decreasing from 73% in 1990 to 40% in 2000.

Workforce

- § Whites had the lowest proportion of people in the labor force: 46%.
- § Hispanics in the labor force decreased 14 percentage points; from 77% in 1990 to 63% in 2000.
- § The percentage of Asians in the labor force also decreased, by 23 percentage points to 64% in 2000.
- § 80% each of both whites and Asians drove alone to work.
- § 10% each of those same groups carpooled in their commute to work.
- § 50% of Hispanic and 51% of Asian youth had both of their two parents in the labor force.

Unlike other areas of the County, the proportion of black youth was much lower than that of seniors,

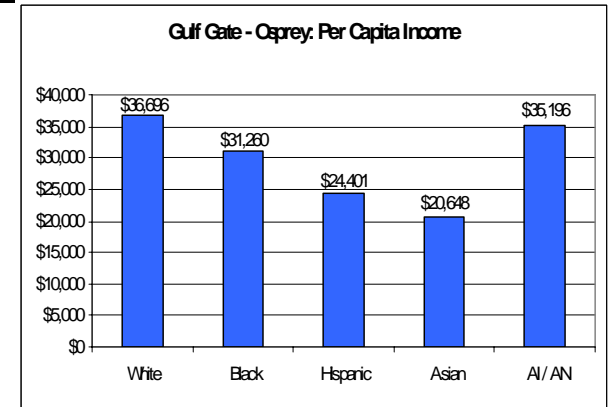
Education

Much of the population in Gulf Gate – Osprey had college degrees.

- § 7% of white people lacked a high school diploma or equivalent, down from 13% in 1990.
- § 16% of both blacks and Asians, and 15% of Hispanics lacked a high school diploma in 2000.
- § Although numbers varied in 1990, in 2000, people with a college degree made up over 40% of all racial groups except the American Indians and Alaska Natives (18% had a college degree).

Poverty and Income

The overall per capita income in Gulf Gate - Osprey was \$36,245.



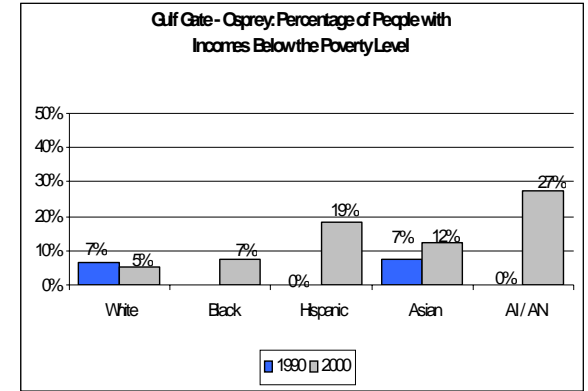
Place of Birth and Citizenship

Most whites, blacks, and American Indians were born in the United States but outside of Florida. The majorities of Asians and Hispanics in Gulf Gate - Osprey were immigrants with low rates of citizenship compared to the rest of the county.

- § 78% of whites were born in a state other than Florida.
- § 79% of blacks were born in a state other than Florida.
- § 51% of Hispanics were born in another country; 41% of this group were citizens.
- § 80% of Asians were born in another country; 34% were citizens.
- § 87% of American Indians and Alaska Natives were born in another state.



Compared to other areas of the county, blacks had higher per capita incomes and a lower rate of poverty.



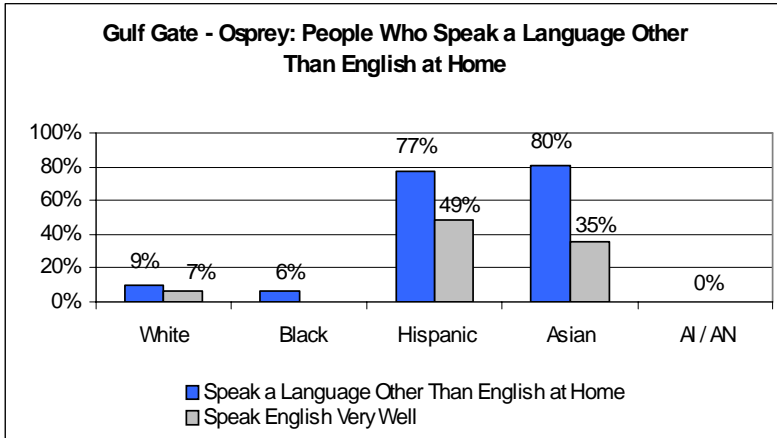
Housing

Although single family homes were more common, slightly higher proportions of people in Gulf Gate – Osprey lived in multi-family homes.

- § Whites had the second-highest proportion of people living in single family homes, 64% of all whites.
- § The majority, 53%, of African Americans lived in multi-family residences in 2000.
- § 76% of American Indians lived in single family houses, the other 24% lived in mobile homes.



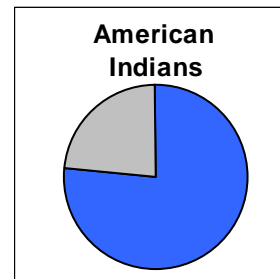
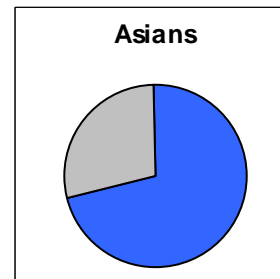
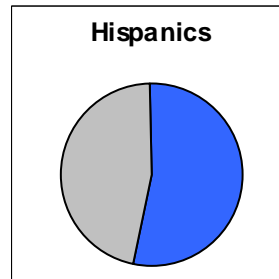
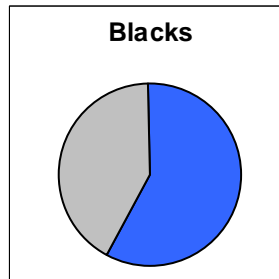
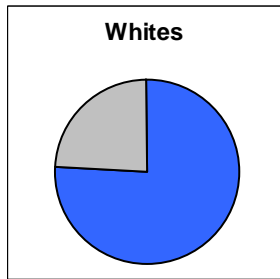

Family Structure

The majority of Longboat Key's households were headed by someone over the age of 65. Much of these elderly householders lived alone. Only one group had married householders with children:

- § The number of white householders who were married with children under 18 increased 132% from 1990 to 2000, but stayed at 2% of all white householders.
- § There were no households of any race headed by a single-female with children in 2000 (there were 8 in 1990, all white).
- § 68% of white householders were over the age of 65, 31% of those elderly householders lived alone.
- § 100% of the Hispanic householders were over the age of 65 and all of them lived alone.



Education

Longboat Key also had the highest percentage in the County of people with advanced (college) degrees and the lowest percentages of those who lacked a high school diploma or equivalent.

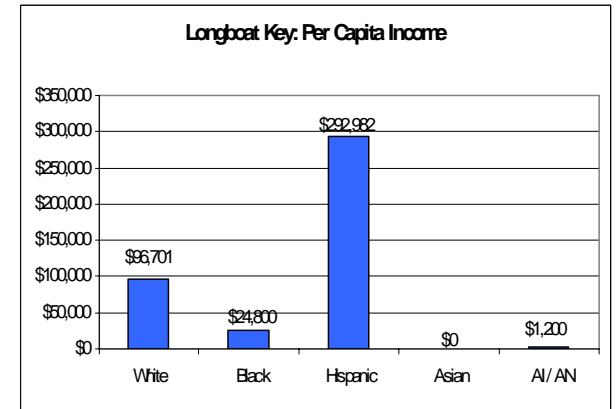
- § 3% of the white population lacked a high school diploma or equivalent, down from 7% in 1990.
- § In 1990, 54% of whites had a college degree, which increased 9 percentage points to 63%.
- § 100% of black people had a college degree.
- § Hispanics with a college degree decreased from 49% of Hispanics in 1990 to 35%.



Poverty and Income

The overall per capita income in Longboat Key was \$96,429.

Hispanics in Longboat Key had that highest per capita income of any group or area of the County.

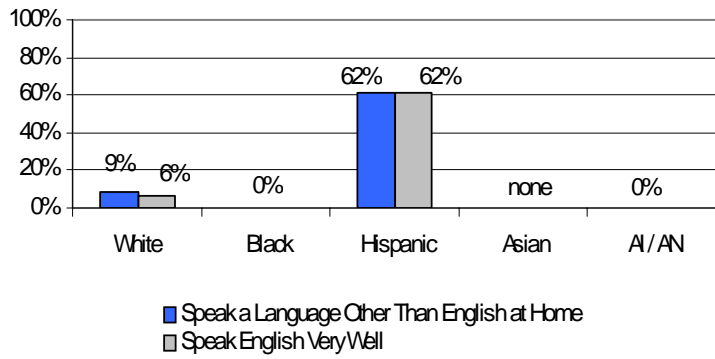
Longboat Key had the highest percentage in the county of whites who were foreign-born. Very few people were born in Florida, with most being from out of state.

- § 84% of whites in Longboat Key were born in a state other than Florida.
- § 13% of white people were from another country; 56% had citizenship.
- § All 7 blacks were born in Florida.
- § 100% of foreign-born Hispanics were citizens.
- § All 9 American Indian / and Alaska Natives were born in a southern state other than Florida.

- § 2% of white people reported incomes below the poverty line in both 1990 and 2000.
- § No other groups reported incomes below the poverty line.

Housing

The majority of people owned their homes, with only a few exceptions. Cost burden was not a problem for many residents.

- § In 2000, 35% of whites lived in single family homes and 62% lived in multi-family residences.

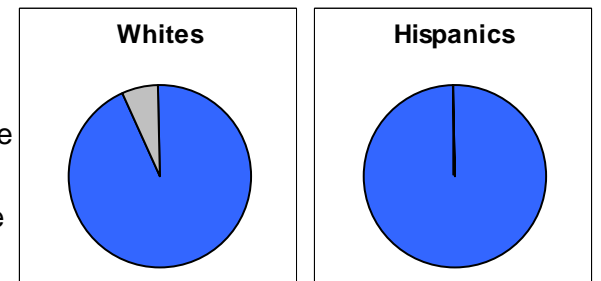

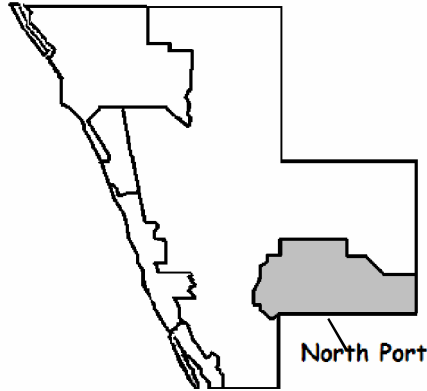

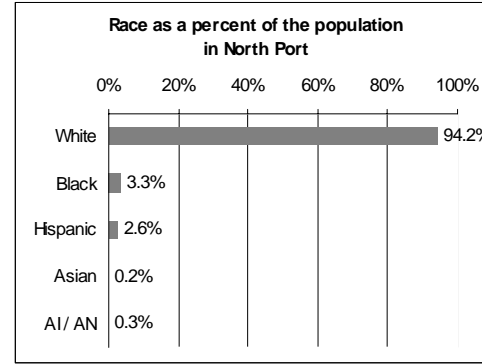

- § The overall population grew 43% from 1990 to 2000.

Family Structure

- The structures of North Port families were not only very diverse, but also changed in the time between censuses.
- § The number of white, married householders with children increased by 115% from 1990 to 2000.
 - § 17% of both white and Hispanic householders were married with children.
 - § The number of white single mothers with children tripled from 1990 and 2000, and went from being 2% of all white households in 1990 to 4% in 2000.
 - § 46% of all white householders were over the age of 65, 35% of them lived alone.
 - § 52% of all black householders were over the age of 65 and 43% lived alone.
 - § Of all Hispanic householders over the age of 65, 55% lived alone.

Education

- North Port was somewhat lower in proportion of people with college degrees. Those without a high school diploma or equivalent also decreased in proportion.
- § 13% of whites lacked a high school diploma or its equivalent, down from 34% in 1990.
 - § The percent of blacks without a high school diploma or its equivalent also decreased: from 75% in 1990 to 30% in 2000.
 - § 20% of both whites and blacks had college degrees in 2000.



Age

Although North Port had slightly higher proportions of youth, seniors represented more of its population.

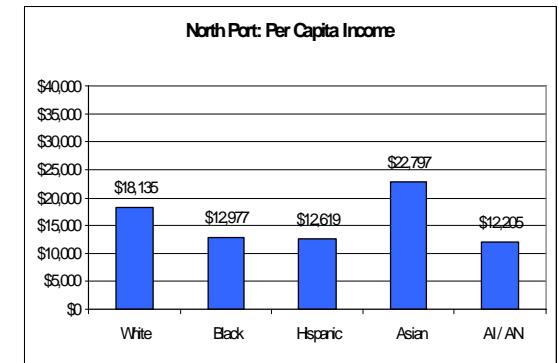

Workforce

- § 47% of whites were in the labor force, the lowest of any group in North Port.
- § 55% of African Americans were in the labor force in 2000 and 10% of those laborers were unemployed.
- § American Indians had the highest rate of unemployment in North Port, 24% of those in the labor force were unemployed.
- § 14% of both whites and blacks carpooled to get to work.
- § 36% of Hispanics carpooled in their commute to work.
- § Less than 1% of whites — 67 individuals — were the only people in North Port who reported using public transit to get to work.
- § For African American children of single parents, 100% of them had that parent in the labor force.
- § For Hispanic children with two parents, 43% of them had both parents in the labor force in 2000.

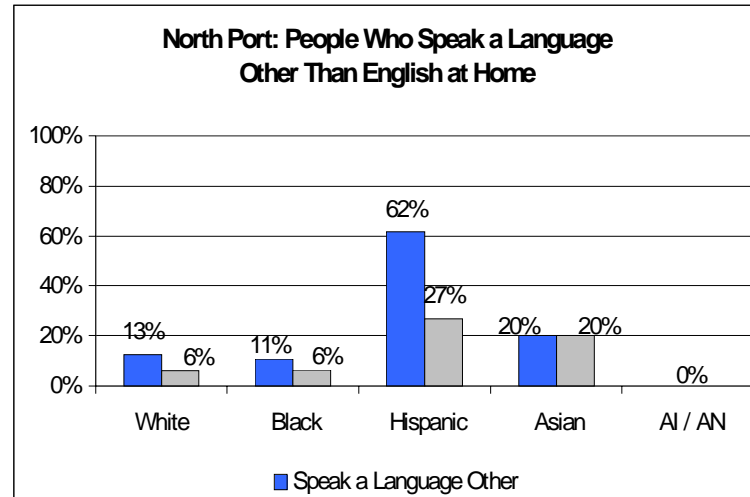
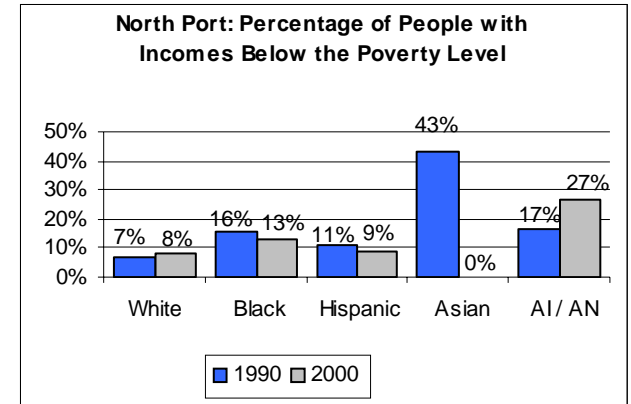
The overall per capita income in North Port was \$18,008.



Place of Birth and Citizenship

Atypical for Sarasota County, North Port had a high proportion of foreign-born whites and blacks. Like the rest of the county, however, much of North Port's population comes from outside of the state of Florida.

- § 70% of whites were born in a state other than Florida and 11% were foreign-born. 53% of foreign-born whites were citizens.
- § 89% of American Indians were born in a state other than Florida.
- § 45% of blacks and 44% of Hispanics were foreign-born.
- § 72% of foreign-born blacks had citizenship, that number for foreign-born Hispanics was 45%.
- § 61% of Asians were foreign-born; 65% of those foreign-born had citizenship.



Housing

The majority of all groups lived in single family detached homes:

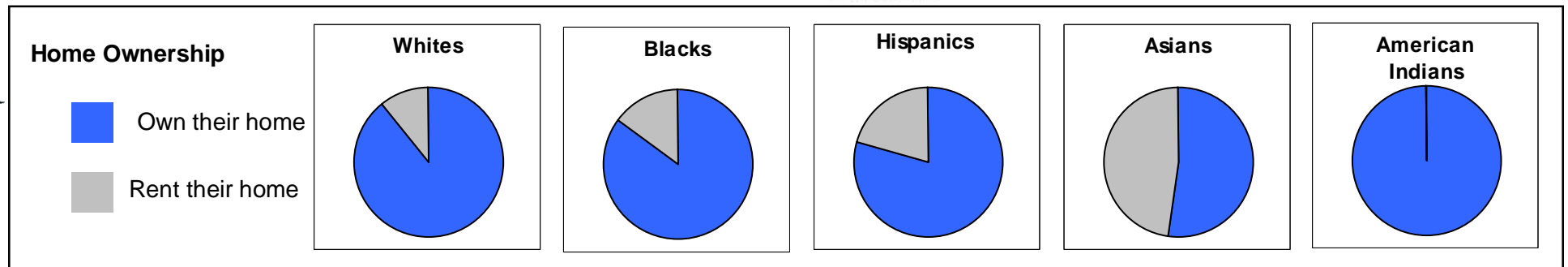

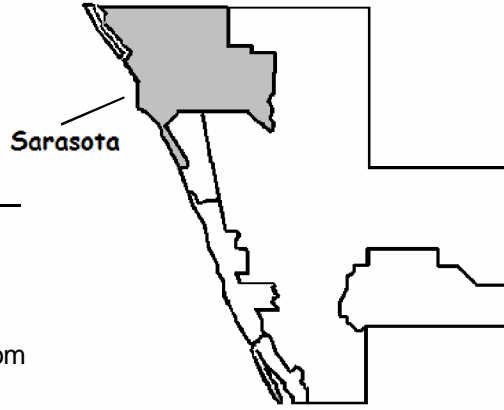

The City of Sarasota (and Greater Area): Census 2000 Highlights



Population

- § 170,140 people lived in the City of Sarasota.
- § The overall population grew 9% from 1990 to 2000.

Family Structure

Households with married couples and children under 18 decreased as a proportion of all groups. Households with a single mother and children under 18 increased slightly for all groups.

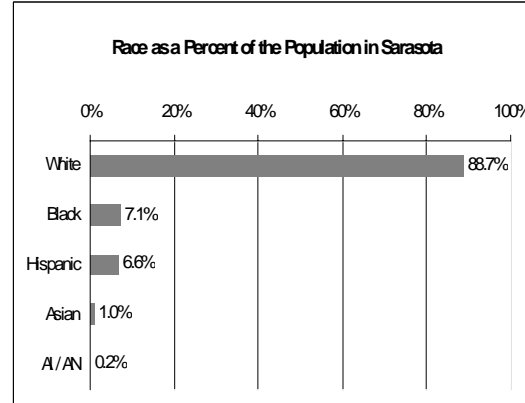
- § Single females were 4% of all white householders in 2000.
- § Single females were 26% of all black householders in 2000, up from 23% in 1990.
- § 37% of Asians householders were married with children.
- § The number of Asian single female householders increased by over 400% to represent 7% of Asian householders in 2000.
- § White householders over the age of 65 were 37% of all white householders.
- § 44% of both white and black householders over 65 lived alone.



Workforce

- § Whites in the labor force stayed at 57% in both 1990 and 2000.
- § Asians were the only group that increased in labor force participation, from 71% to 73% over ten years.
- § White and Asian workers were more likely to drive alone to work – 82% of white workers and 83% of Asian workers got to work that way.
- § 7% of blacks used public transit to get to work making them the highest users of this service among all groups in the City of Sarasota.
- § Hispanics were most likely of any group to carpool in their commute to work – 22% of all Hispanic workers carpooled.

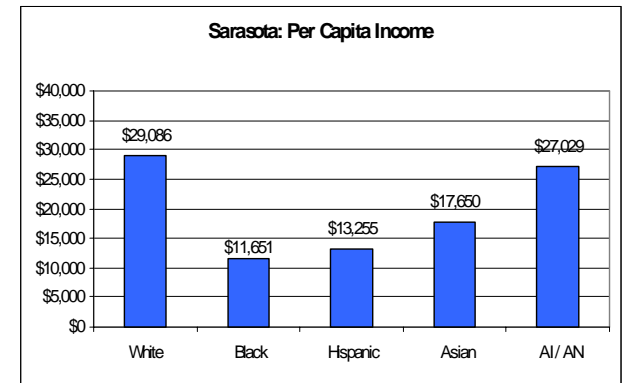

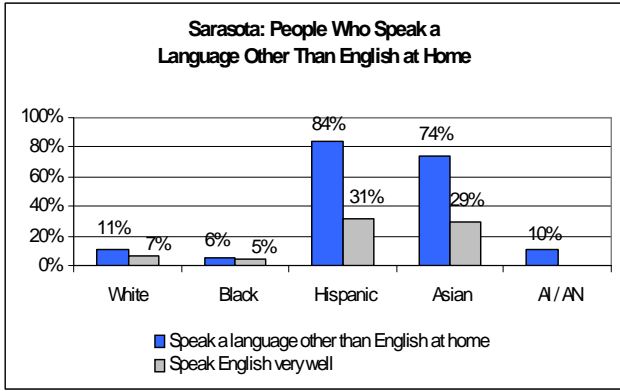
There was a dramatic decrease in the proportion of individuals who lacked a high school diploma or equivalent. Also, some groups saw a significant increase in the proportion of people with college degrees.

- § People who lacked either a high school diploma or its equivalent decreased from 22% to 8% of the white population.

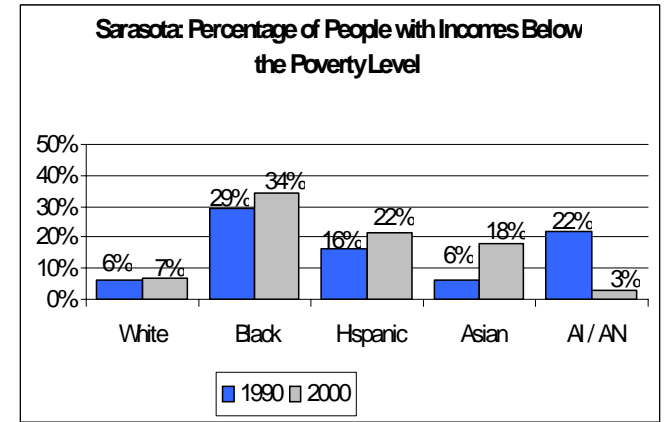


Place of Birth and Citizenship

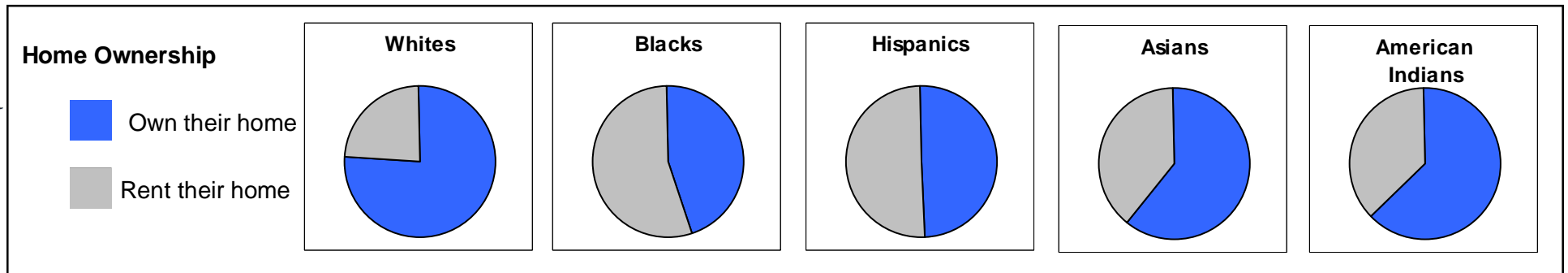

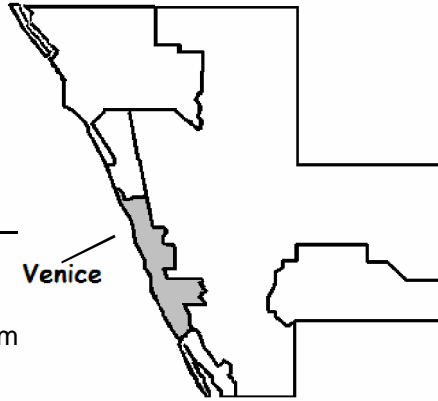

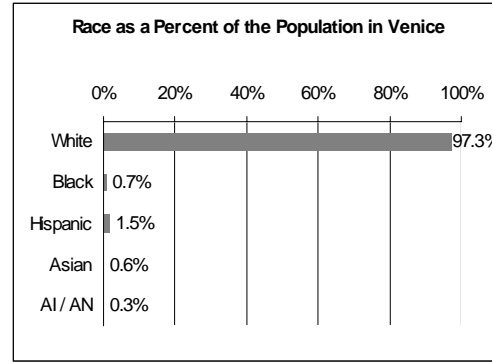
Family Structure

- § Married, white householders with children stayed at 10% of the white population from 1990 to 2000.
- § The same group for Hispanics grew from 8% to 33% of all Hispanics during the same time.
- § 18% of all black households consisted of a single female with children, down slightly from 19% in 1990.
- § Of white households, 53% are headed by an adult over the age of 65; 40% of these older adults live alone.
- § Although blacks have the lowest proportion of householders over the age of 65, they have the highest percentage (in Venice) of elderly householders who live alone: 56%.



Workforce

- § 44% of whites were in the labor force.
- § 67% of African Americans were in the labor force, up from 44% in 1990.
- § American Indians and Alaska Natives had the highest rate of labor force participation, 85%

- § 7.2% each of both Hispanics and Asians walked or biked to work.
- § 100% of black and American Indian youth with only one parent had that parent was in the labor force.
- § Hispanic children were less likely to have their parents in the labor force: 67% of children from two-parent families and 73% of children from one-parent families had their both or their only parent in the labor force.



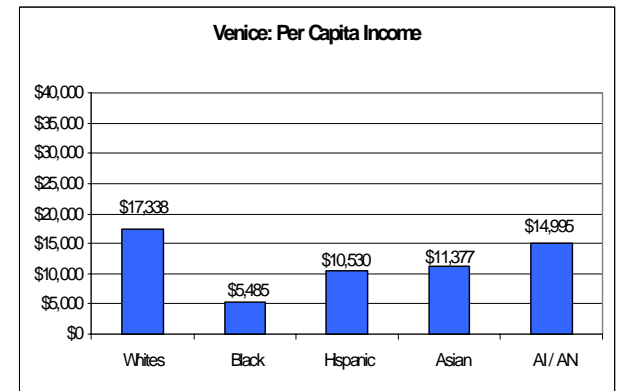

Education

- § Venice improved in the proportions of people with formal education certification. That is, there were generally fewer people who had dropped out of high school and more people with advanced degrees from colleges.
- § The proportion of white people without a high school diploma or its equivalent decreased from 26% in 1990 to 10% of all whites in 2000.
- § Those same numbers for blacks went from 66% in 1990 to 56% of all blacks in 2000.
- § 43% of all Hispanics had some type of college degree, 574% more people than in 1990.
- § 29% of Asians lacked a high school diploma, 32% of Asians had a college degree.

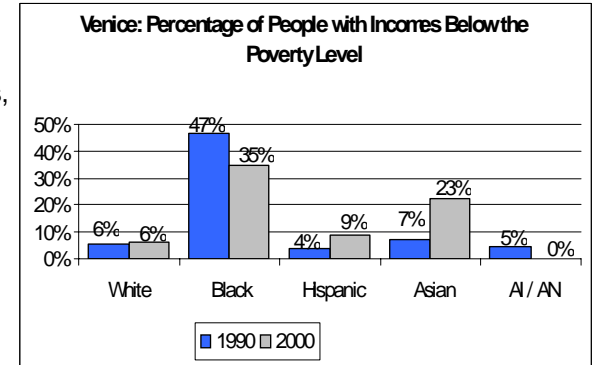

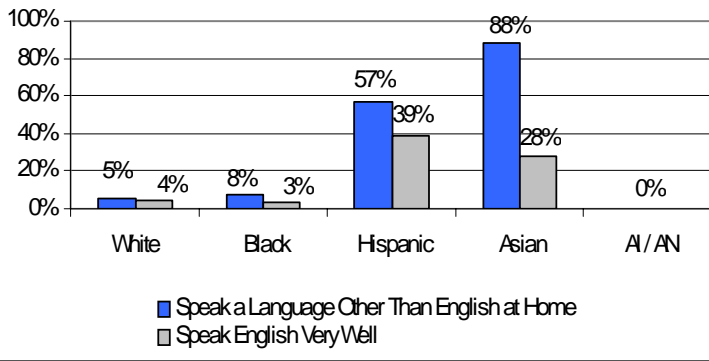
Venice follows the pattern of many other places in the county: most whites and American Indians were born in a state other than Florida, most blacks were born in Florida, and the majority of Asians were foreign-born. Hispanics, however, were mostly from other states or territories in the United States.

- § 81% of white people in Venice were born in a state other than Florida.
- § 70% of black people were born in Florida.
- § 46% of Hispanics were born in another state with most (54%) coming from the Northeast.
- § Of foreign-born Hispanics (36% of all Hispanics), 47% were citizens.
- § 71% of Asians were born in a foreign country; 52% were citizens.
- § 77% of American Indians were born in another state; of those, 73% were born in the Northeast.

Blacks in Venice had the highest rate of poverty among all African Americans, slightly higher (1%) than those in Sarasota.

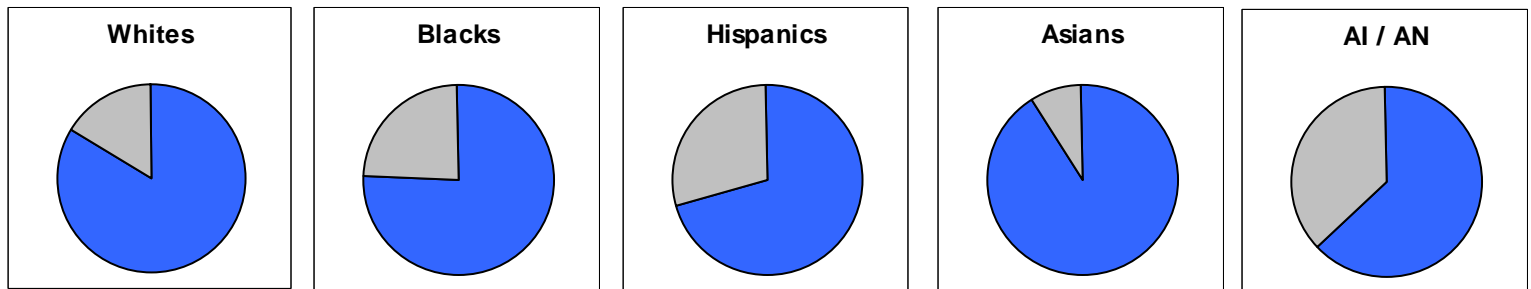
The majority of all groups were homeowners. Renters were generally more cost-burdened than homeowners except in the case of African Americans, where the burden of housing costs fell similarly on both owners and renters.

- § 93% of blacks lived in single family homes and the other 7% lived in multi-family residences in 2000.
- § Like whites, 15% of Hispanics lived in multi-family residences in 2000, but more – 80% of Hispanics – lived in single family homes (72% of whites lived in single family homes).
- § 15% of American Indians lived in mobile homes, the other 85% lived in single family houses in 2000.

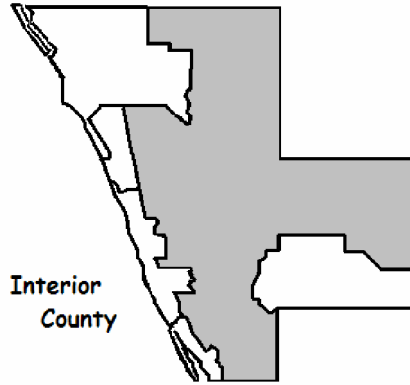

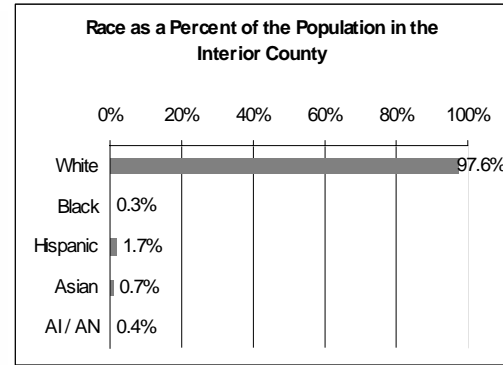

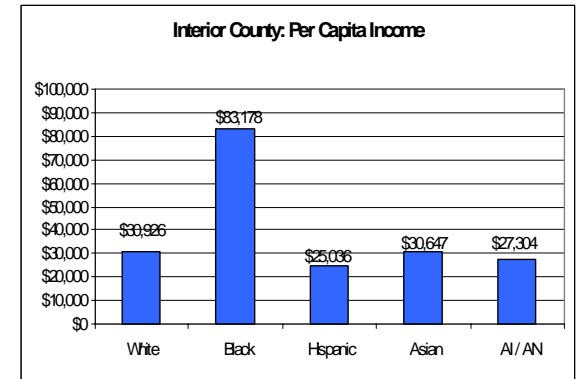

Education

- Interior County increased significantly in the proportion of people who had formal education. More people had college degrees and fewer people were without a high school diploma or equivalent.

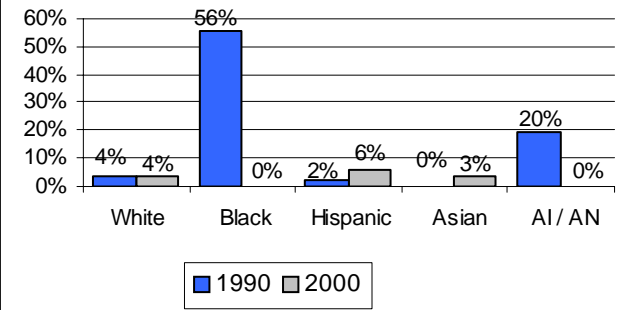

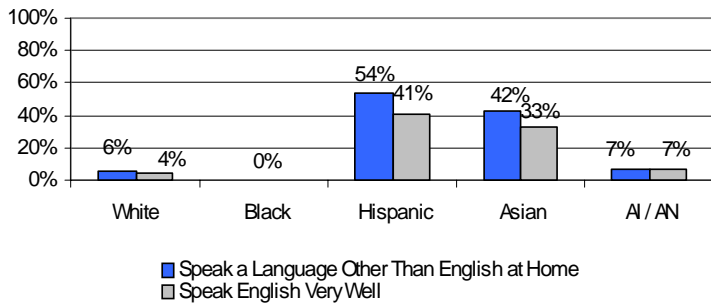

Interior County: People Who Speak a Language Other Than English at Home



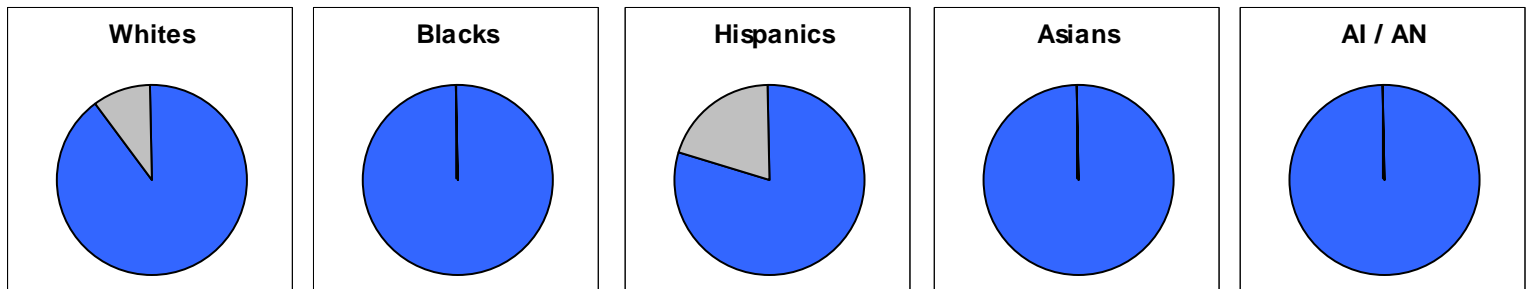

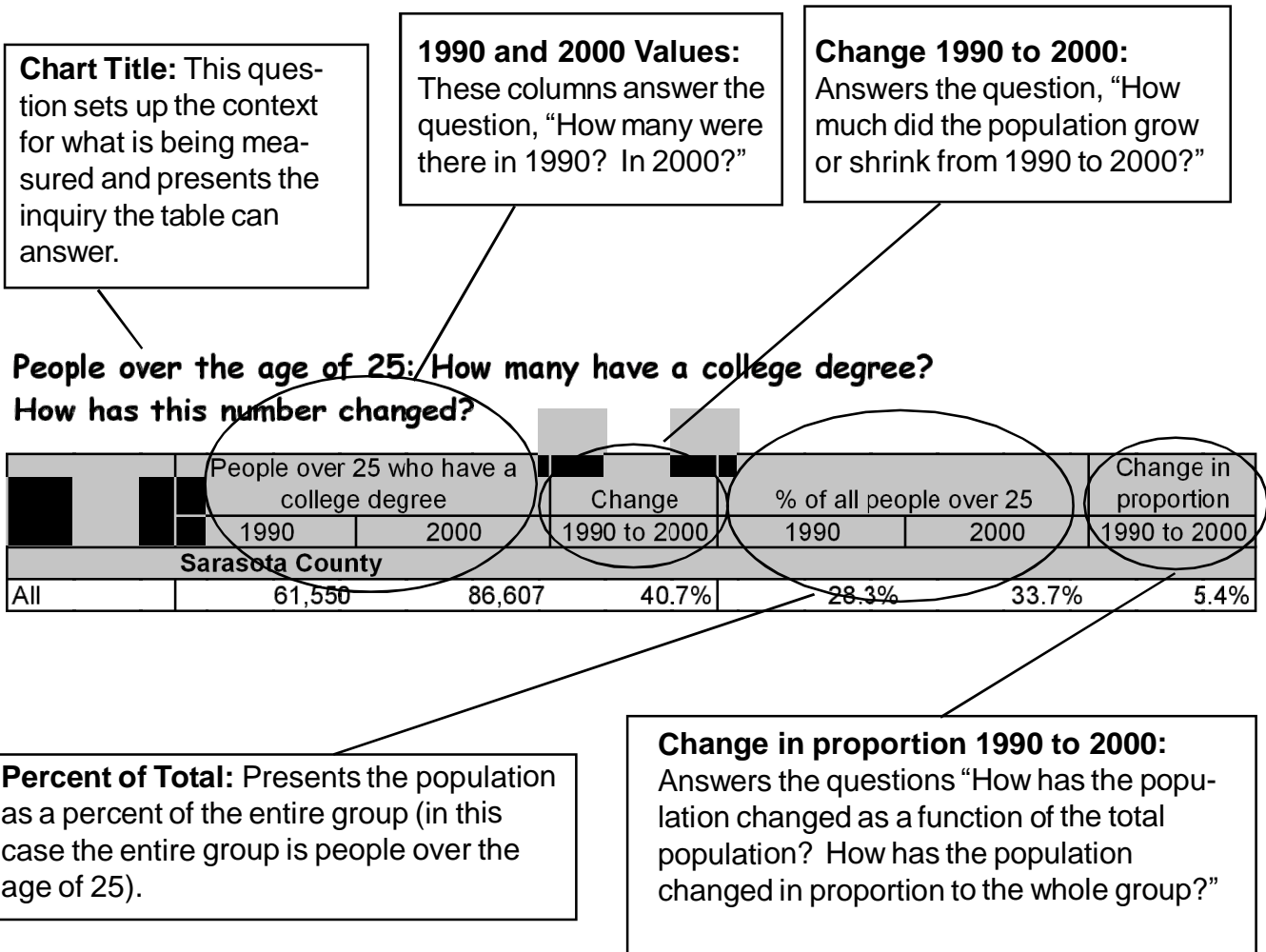

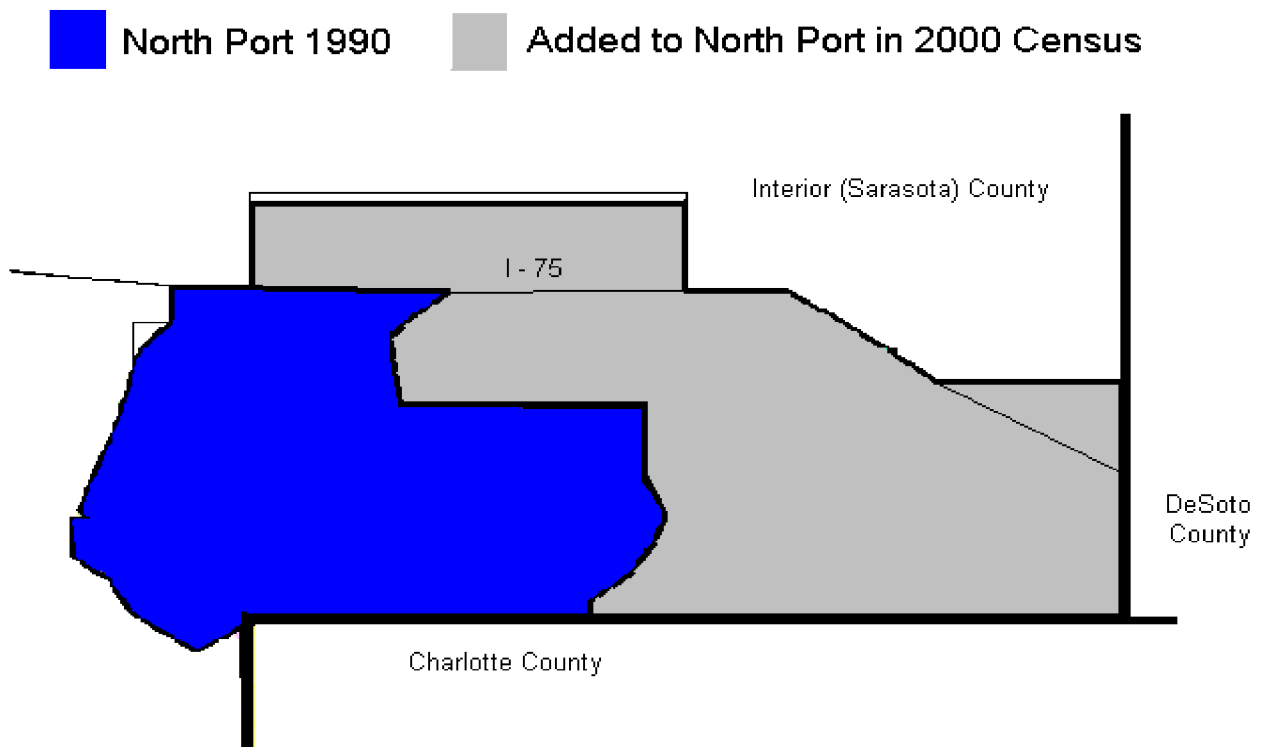

Appendix 1: 1990-2000 Boundary Changes in County Areas

Appendix 2: Glossary of Terms and Special Notes

30% or more	The Department of Housing and Urban Development considers paying more than 30% of household income on total housing costs as being "cost burdened" or paying too much.
all parents	In reference to the employment status of parents, 'all parents' means that all of a child's parents are in the labor force (see 'labor force') whether they live with their mother and father or only their mother or only their father.
black or African American	A person having origins in any of the Black racial groups of Africa. It includes people who indicate their race as "Black, African Am., or Negro," or provide written entries such as African American, Afro-American, Kenyan, Nigerian, or Haitian.
census designated place	A statistical entity, defined for each decennial census according to Census Bureau guidelines, comprising a densely settled concentration of population that is not within an incorporated place, but is locally identified by a name. CDPs are delineated cooperatively by state and local officials and the Census Bureau, following Census Bureau guidelines.
earnings	Earnings are defined as the sum of wage or salary income and net income from self-employment. Earnings represent the amount of income received regularly for people 16 years old and over before deductions for personal income taxes, social security, bond purchases, union dues, Medicare deductions, etc.
foreign born	The foreign-born population includes all people who were not U.S. citizens at birth. Foreign-born people are those who indicated they were either a U.S. citizen by naturalization or they were not a citizen of the United States.
gross rent	Gross rent is the contract rent plus the estimated average monthly cost of utilities (electricity, gas, water and sewer) and fuels (oil, coal, kerosene, wood, etc.) if these are paid by the renter (or paid for the renter by someone else). Gross rent is intended to eliminate differentials that result from varying practices with respect to the inclusion of utilities and fuels as part of the rental payment.
Hispanic or Latino	Hispanic origin can be viewed as the heritage, nationality group, lineage, or country of birth of the person or the person's parents or ancestors before their arrival in the United States. People who identify their origin as Spanish, Hispanic, or Latino may be of any race.
household	A household includes all of the people who occupy a housing unit (see 'housing unit').
household income	Income is the sum of the amounts reported separately for wage or salary income; net self-employment income; interest, dividends, or net rental or royalty income or income from estates and trusts; social security or railroad retirement income; Supplemental Security Income (SSI); public assistance or welfare payments; retirement, survivor, or disability pensions; and all other income.
householder	One person in each household is designated as the householder. In most cases, the householder is the person, or one of the people, in whose name the home is owned, being bought, or rented. If there is no such person in the household, any adult household member 15 years old and over could be designated as the householder.
housing unit	A housing unit may be a house, an apartment, a mobile home, a group of rooms, or a single room that is occupied (or, if vacant, is intended for occupancy) as separate living quarters. Separate living quarters are those in which the occupants live separately from any other individuals in the building and which have direct access from outside the building or through a common hall.
labor force	Individuals in the labor force include both those who are employed and those who are unemployed. Employed individuals are those who worked during a reference week referred to in the census questionnaire. Unemployed individuals include those who did not work during the reference week but have been both looking for employment and are available for employment.

married	Now married includes people whose current marriage has not ended through widowhood or divorce; or who are not currently separated. The category also may include people in common-law marriages if they consider this category the most appropriate.
median	This measure is the middle value of an ordered list of cases (such as the different ages or incomes of all people in the county). The median divides the number of cases in two equal parts: one-half of the cases falling below the median and one-half above the median.
mobile home	Both occupied and vacant mobile homes to which no permanent rooms have been added are counted in this category. Mobile homes used only for business purposes or for extra sleeping space and mobile homes for sale on a dealer's lot, at the factory, or in storage are not counted in the housing inventory.
multi-unit	These are housing units (see 'housing units') in structures containing 2 or more housing units.
Neighborhood	For the purposes of this report, neighborhoods are geographic areas designated by the U.S. Bureau of the Census called Census Designated Places. See 'Census Designated Places'.
occupied housing unit	A housing unit (see 'housing unit') is classified as occupied if it is the usual place of residence of the person or group of people living in it at the time that the census survey is conducted, or if the occupants are only temporarily absent; that is, away on vacation or a business trip.
owner occupied unit	A housing unit (see 'housing unit') is owner occupied if the owner or co-owner lives in the unit even if it is mortgaged or not fully paid for. The owner or co-owner must live in the unit.
poverty level	To determine a person's poverty status, one compares the person's total family income with the poverty threshold appropriate for that person's family size and composition. If the total income of that person's family is less than the threshold appropriate for that family, then the person is considered poor, together with every member of his or her family.
real growth	When referring to changes in dollar values from 1990 to 2000, real growth means dollar growth after correcting for changes in price levels (inflation). Price levels increased by 34% from 1989 to 1999, the years in which the 1990 and 2000 censuses, respectively, referred to regarding income. Price level changes were calculated using the U.S. Bureau of Labor Statistics consumer price index for all urban consumers, U.S. city average.
renter-occupied unit	All occupied housing units (see 'occupied housing unit') that are not owner occupied, whether they are rented for cash rent or occupied without payment of cash rent, are classified as renter occupied.
sample data	Information collected from the census long form for a one in six sample of households in the United States.
selected owner costs	Selected monthly owner costs are the sum of payments for mortgages, deeds of trust, contracts to purchase, or similar debts on the property (including payments for the first mortgage, second mortgage, home equity loans, and other junior mortgages); real estate taxes; fire, hazard, and flood insurance on the property; utilities (electricity, gas, and water and sewer); and fuels (oil, coal, kerosene, wood, etc.).
Single unit	This is a 1- housing unit (see 'housing unit') structure that either a) has open space on all four sides or b) one or more walls extending from ground to roof separating it from adjoining structures. In row houses (sometimes called townhouses), double houses, or houses attached to nonresidential structures, each house is a separate, attached structure if the dividing or common wall goes from ground to roof.

Appendix 2 (cont.): Glossary of Terms and Special Notes

single-family owner-occupied house	This term includes owner-occupied units (see 'owner-occupied units') that are 1-family houses on less than 10 acres. The term excludes mobile homes, houses with a business or medical office, houses on 10 or more acres, and housing units in multiunit buildings.
speak English less than "very well"	Census respondents who reported that they spoke a language other than English in long-form questionnaire Item 11a were asked to indicate their ability to speak English in one of the following categories: "Very well," "Well," "Not well," or "Not at all."
white	A person having origins in any of the original peoples of Europe, the Middle East, or North Africa. It includes people who indicate their race as "White" or report entries such as Irish, German, Italian, Lebanese, Near Easterner, Arab, or Polish.
